



**MEMORANDUM OF UNDERSTANDING  
BETWEEN  
NHA TRANG UNIVERSITY  
Nha Trang, Vietnam  
AND  
NATIONAL TAIWAN OCEAN UNIVERSITY  
Keelung, Taiwan**

Nha Trang University and National Taiwan Ocean University enter into this agreement to foster international cooperation in education, research economic development and fulfilling the university's social responsibility.

1. The parties agree to encourage the following activities in particular to promote academic cooperation:
  - a. Joint conference for every two years in respective university;
  - b. Exchange of faculty member,
  - c. Exchange of graduate and / or undergraduate students;
  - d. Dual degree for graduate student;
  - e. Exploration of possibilities for collaboration research.
  - f. The university's social responsibilities among universities include academic cooperation, teaching cooperation and fostering the local industry development.

Before specific activities can be implemented, the parties shall develop and enter into specific activity agreements based on the form of implementation mutually agreed upon subsequent to this Agreement. Implementation of specific collaborative programs will depend upon the availability of funds and continued mutual interest of the partners. Nha Trang University and National Taiwan Ocean University will assist each other with applications to funding agencies for financial support when deemed appropriate by both parties.


2. Both institution subscribe to a policy of equal opportunities and will not discriminate on the basis of race, gender, ethnicity, religion, national origin, or disability.
3. The Agreement becomes effective upon affixing the last required signature. It shall remain in force for five (5) years and may be renewed by the written agreement of the parties. The Agreement should be reviewed every five years. The Agreement may be terminated by either party upon at least 90 days in advance written notice. Such termination shall not affect activities in progress at the time the notice is received.

4. This Agreement constitutes the entire agreement between the parties, and all prior discussions, agreements and understandings, whether verbal or written, are hereby merged into this Agreement. This Agreement is not considered a binding contract creating legal and financial relationships between the parties, but is designed as a means to facilitate and develop a genuine and mutually beneficial process for collaboration.
